The EEPLIANT project was designed to help deliver the intended economic and environment benefits of the Energy Labelling and Ecodesign Directives by increasing the rates of product compliance with them.

The team, consisting of 13 Market Surveillance Authorities from across the EU and PROSAFE, has organised coordinated monitoring, verification and enforcement activities, including product testing of LED lamps, imaging equipment and heaters between March 2015 and June 2017.

Within the project, numerous products have been verified for formal and technical compliance. Surveillance authorities have discussed results with economic operators and professional stakeholders, and acted to remove non-compliant products from the market. The authorities have worked together to develop and adopt best practices and establish collaborative approaches to improve product compliance in the EU market.
