The EEPLIANT2 project was designed to continue the EEPLIANT2014 programme of helping to deliver the intended economic and environment benefits of the Energy Labelling and Ecodesign Directives by increasing the rates of product compliance with them.

The team, consisting of 17 Market Surveillance Authorities from across the EU, with PROSAFE as a coordinator, has organised coordinated monitoring, verification and enforcement activities, including product testing of domestic and professional refrigeration and network standby between September 2017 and February 2020.

EEPLIANT2 verified numerous products for formal and technical compliance. Surveillance authorities notified economic operators and professional stakeholders and acted to remove non-compliant products from the market. The partners have worked together to develop and adopt best practices and establish collaborative approaches to improve product compliance in the EU market.



What are the final results, lessons learned, actions taken, and plans for the future?

The final conference of EEPLIANT2 will reveal worrying high rates of noncompliance. Whilst reactive market surveillance is a must, it is time to take a different tack. We believe proactive market surveillance guides the sustainable way forward to achieve the H2020 and H2030 energy efficiency goals. Therefore, the results deserve further analysis and an investigation of potential trends comes at the right time with the closure of the EU-funded Action. To discuss the way forward and how to address the high level of noncompliance we organise together with the European Commission a brainstorming workshop on 5 February dedicated only to the market surveillance authorities. A separate agenda for this event will be circulated swiftly.
