Authorities must enforce the regulations to protect the interests of reputable businesses - but suppliers are all busy and how can they be sure they are compliant themselves? Will your marketing material be fully compliant and ready for HOST 2019 in October?

It can be hard to get to grips with so many regulations, but EFCEM and EEPLIANT2 project can help and are running a **webinar on morning of Thursday 5 September 2019** that will explain in simple terms exactly what is required from supplier's technical and marketing teams regarding energy labelling and ecodesign requirements.

This free-of-charge webinar is delivered through joint working of several EU market surveillance authorities - so be assured that you are getting authoritative guidance on these questions below and more, via the EU EEPLIANT2 project, and EFCEM:

- What benefits do I have as a manufacturer/supplier from all those regulations?
- What will a market surveillance authority inspector ask of me as an importer? Or as a dealer?
- Do I need test reports for all cabinet models?
- How do the climate classes on energy labels and in testing work?
- What makes energy labels and the fiche so important? And how can I persuade my colleagues of that?
- What exactly has to be in a 'Declaration of Conformity'?
- Do I have to show labels at trade fairs such as HOST 2019?
- What has to be kept in a 'Technical Documentation File' that I must give to the authority when asked

We will also discuss overall lessons from recent lab testing of 30 professional cabinets and inspection of technical documentation of over 50 cabinets across Europe under the EEPLIANT2 project.
